
Properties can be let if they have an energy rating from A to E.

Energy rating and score

Primary energy use

The primary energy use for this property per year is 319 kilowatt hours per square metre (kWh/m2).

How this affects your energy bills

An average household would need to spend £2,027 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.

You could save £923 per year if you complete the suggested steps for improving this property's energy rating.

Changes you could make

8. Condensing boiler	£2,200 - £3,000	£301
9. Solar water heating	£4,000 - £6,000	£80
10. Solar photovoltaic panels	£3,500 - £5,500	£586
